

The development team reaffirmed to the standing room only group of residents who convened for the community-wide meeting that it is on track with fulfilling the Freedom West 2.0 Guiding Principles that were created by the resident board and voted on by the full community representing approximately 1,000 existing residents. This achievement is despite the many barriers and obstacles that a bold and complex plan such as Freedom West 2.0 must continue to work through to make this \$2.3B revitalization mission a reality.

"I'm still flying high from this past Saturday's Freedom West 2.0 Shareholder Resident update event," said Landon later in the week. "From day one we have made sure this revitalization plan was anchored on resident agency and driven by the mission to empower the Freedom West resident owners with long-term economic self-sustainability and parity."

After he thanked the Shareholder Residents for their participation, MacFarlane Partners Strategy Consultant Ramsey Jay, Jr. stepped up to ask each and every member of the Freedom West board of directors and development team to raise their right hand – which became an extended several minutes – representing their determination and commitment to the project and the role each person needs to continue to take on in order to make the Freedom West 2.0 vision and mission a reality for the resident community.

"Throughout the day, the dynamic interplay between Freedom West Shareholders, Board Directors, and the Development Team epitomized the inclusive, equitable, and parity zone ethos of the Freedom West 2.0 redevelopment," said Ramsey. "This is a practical model of community transformation, and one that may prove to be a national example going forward."

"It is powerful to see our Shareholders come together with the Board and development leadership to work together to impact this awe-inspiring goal," said Freedom West Board President, Mattie Scott. "I believe we all went back to our residences with renewed hope that the change we have been envisioning is becoming clearer – and we'll work together to make that happen."
